

# **2017 Stall Application & Horse People's Information Guide**





Welcome Back Horse People,

We are eagerly preparing for our 120<sup>th</sup> season of live racing at Fort Erie, and are looking forward to having our horse people, horses and racing fans return to the border oval for what is sure to be another great season.

We are excited about the announcements by the government to continue to fund the industry for another 20 years and the prospect of working with the industry to ensure Fort Erie sees better times ahead. We hope that this stability encourages you to plan your future both short-term and long.

Our 2017 season will begin on Tuesday, May 30<sup>th</sup> with the return of our popular Twilight Tuesday program. Closing Day will be Tuesday, October 17<sup>th</sup>.

This year we will be opening the backstretch earlier than previous years. You may begin to set up your stalls on Friday, April 7, and horses may begin to ship in on Sunday April 9. The dirt track will be open for training on Saturday, April 29. Training hours are 6am to 10:30am with a break as needed for harrowing. In advance of the track opening for training, and throughout the year, we have installed a new Odyssey Horse Exerciser that will be ready for use this spring. It is located between barns 5 and 5A on the west side, and will be \$3 per use.

## **Additional Information**

- RACING DAYS and POST TIMES will be different this season. Please see the attached racing schedule for more information.
- Ontario Sired PURSE BONUS will stay in effect, without any changes, for ALL eligible horses
- FIRE SAFETY is always a serious concern. FELRC staff will be closely monitoring compliance with our fire safety regulations; this also includes proper hay and straw storage.
- ACCESS FORMS must be signed by everyone allowed on the backstretch. Once you have signed your form you will receive an access sticker from security which allows you on the premises.
- The practice of closing the race track for training on Wednesdays will commence in July
- Trainers are encouraged to use straw and/or shavings for stall bedding. Any other forms of bedding must be approved by the Race Office.

## **Frequently Asked Questions**

### ***Where is Fort Erie Race Track located?***

Fort Erie Race Track is located just across the Peace Bridge from Buffalo, New York. It is only a 15-minute drive to Niagara Falls, and 1.5-hour drive to Woodbine Racetrack.

### ***When is the racing season?***

Live racing begins on Tuesday, May 30 and runs until Tuesday, October 17.

### ***What are the racing days?***

Fort Erie hosts a total of 40 race days. Live racing runs Tuesdays & Sundays in June and July, and Tuesdays & Saturdays in August, September & October. Throughout the summer, we offer Twilight racing beginning at 4:20 pm on Tuesdays in June, July & August, and Saturdays in August.

### ***What types of races does Fort Erie offer?***

We offer dirt and turf racing. Our bottom claiming price is \$3,000. We also offer a series of Cup races, starter allowances and write distances from as short as 2 furlongs and as long as 2 miles and 70 yards.

### ***How do I arrange for storage sheds and bins?***

Security staff will assign storage rooms (Tack Rooms) for tack and feed. You may contact Harry Eder at ext. 3602 to arrange bins.

### ***What are the entry times?***

Thursday entries are taken for Sunday cards, Friday entries are taken for Tuesday cards. Beginning Wednesday, August 2, entries will be taken on Wednesdays for Saturday cards. \*Entries will close at 11:30 A.M. unless otherwise noted.

### ***What paperwork do I need to have when I ship in?***

Foal papers for all the horses you are bringing in (ORC RULE 29.08), a copy of your Worker's Compensation Clearance Certificate for 2017, and a list of horses you are bringing in. In and Out slips will be required for all horses during the 2017 season.

### ***What are the training hours?***

May through October: 6:00 A.M. – 10:00 A.M. (Race Days)  
6:00 A.M. – 10:30 A.M. (Dark Days)

Track closed for training on Wednesdays starting in July  
(Subject to change)

### ***When will the starting gate be available for training?***

The gate will open on May 14 and will be available Saturday through Tuesday throughout the racing season. (Subject to change)

### ***Are there living quarters?***

There is a limited number of rooms that will be assigned to hot walkers and grooms only. Anyone wanting a room should contact the security staff.

## The 82nd Edition of the Prince of Wales Stakes

The 2<sup>nd</sup> Jewel in the Canadian Triple Crown will take place on Tuesday, July 25<sup>th</sup> for a purse of \$500,000.

The race will be run at a distance of 1 mile and 3/16<sup>th</sup> on the main dirt track for 3 year olds foaled in Canada with a maximum field of 12 starters. The purse will be divided 60% to the winner, 20% for second, 10% for third with the fourth and fifth place finishers to receive purse as per the association scale.

This is the highest purse offered on a dirt surface in Canada

- A negative Coggins test certificate, valid for 180 days \*Please note: Eliza Test is not acceptable.
- All persons traveling to and from Canada will require a valid passport and may be required to have a visitor's visa for entry into Canada.

## **APPLICATIONS OF ACCESS RIGHTS**

### **FORT ERIE LIVE RACING CONSORTIUM APPLICATION FOR ACCESS RIGHTS**

#### **THOROUGHBRED**

To: Fort Erie Live Racing Consortium ("FELRC")

I hereby apply, either (a) in my personal capacity or (b) as an employee, agent, or representative (an "Agent") of an individual, corporation or other legal entity (the "Principal"), for a limited, non-transferable, revocable license (the "access rights") to enter upon land and premises operated by the FELRC and the improvements located thereon (the FELRC premises') together with the property (including horses and equipment) in my possession, care, custody or control from time to time during the proposed access.

I undertake and agree to use the access rights, if granted, for the limited purpose of such activities on FELRC premises as may be permitted by FELRC and, in the case of equine and related activities, to abide by the Rules and Regulations of FELRC as amended from time to time.

I acknowledge and agree that FELRC reserves the right to revoke the access rights, if granted, at any time in its sole and absolute discretion and without notice, reason or compensation.

I acknowledge and agree that the term "property", whenever used, includes horses and the term "damage to property" includes injury to or death of horses.

#### **Authority to sign this Application**

Where this is an Application for Access Rights made in my personal capacity. I represent and warrant that I am 18 years of age or older. Where this is an Application for Access Rights made as Agent of a Principal, I represent and warrant that the Principal, if an individual, is 18 years or older and I am authorized by the Principal to sign this Application for Access Rights and thereby bind the principal to its terms in the same manner as if this Application were signed by the Principal.

#### **Acknowledgement and Assumption of Risk**

I acknowledge that working with and riding horses, handling equine equipment and otherwise engaging in equine activities is dangerous and involves inherent risk of injury and death and loss of damage to property, and I hereby agree to assume that risk.

Without in any way limiting the generality of the foregoing, I acknowledge that:

- a) Horses have the propensity to behave in unpredictable ways that may result in injury or death or loss of or damage to property;
- b) The use of equine equipment, including safety equipment, may not reduce the risk of injury or death or loss of or damage to property;

- c) The condition of FELRC premises, including without limitations the racetracks and practice tracks and stables, are imperfect and may contain hidden or unknown hazards that increase the risk of injury or death or loss of or damage to property;
- d) Engaging in competitive activities, including racing, involves unpredictable and unknown hazards and dangers; and
- e) The use of FELRC premises by others or the engaging by others in competitive activities, including racing, may result in unexpected or unknown danger that increases the risk of injury or death, or loss of or damage to property.

I acknowledge and agree that FELRC makes no representations or warranties, whether written or oral, express or implied, respecting:

- a) FELRC premises or their suitability or fitness for any particular purpose, including without limitation that portion of FELRC premises on which any equine events or related activities take place;
- b) The competence or qualifications of others having access right to FELRC premises, including without limitations their competence or qualifications to engage in racing or training;
- c) The state of health or safety of horses on FELRC premises from time to times;
- d) The supervision, control or raining of horses on FELRC premises from time to time, including without limitations their suitability for training and racing.

I acknowledge having been provided with a copy of the Rules and Regulations of Fort Erie Racetrack and acknowledge that compliance with those Rules and Regulations, as amended from time to time, is a condition of my continued access to FELRC premises.

#### **Conditions of Access - Waiver, Release of Claims and Indemnity**

In consideration of the grant or proposed grant to me by the FELRC premises, I hereby waive the forever release FELRC and its current and former officers, directors, employees and agents (collectively referred to as the "Releasees") from any and all claims of any sort (excepting any claim for want of ordinary care or negligence on the part of FELRC or its officers, servants, agents or employees) which I may otherwise now have or may have or acquired in the future, whether or not such claims are within my current knowledge or contemplation, including without limitations all claims arising out of injury, death, loss of or any damage to person or property, which directly or indirectly arise out of, relate to are a consequence of or follow the granting or proposed granting, or the use or proposed use of access rights by me as contemplated in this application.

For the same consideration, I undertake and agree in indemnify and hold harmless FELRC and the other Releasees in respect of all claims as against them (excepting any claim for want of ordinary care or negligence on the part of FELRC or its officers, servants, agents or employee), including without limitations all claims arising out of injury, death, loss of or damage to person or property as well as the actual legal costs incurred by FELRC in responding to such claims, which directly or indirectly arise out of, relate to, are a consequence of or follow the granting or proposed granting, or the use of proposed use, of the access rights by me as contemplated in this Application.

In consideration of being allowed any stabling accommodation on the premises of Fort Erie Race Track

**I agree to the following terms and conditions:**

- 1.] **THE APPLICANT** agrees to abide by and comply with all the rules and regulations of the Ontario Racing Commission [ORC] and of Fort Erie Race Track - F.E.L.R.C..

**Policy Note:** In consideration of agreeing to permit any horse owner, trainer and their respective directors, officers, employees, principals, agents and guests, access to the premises and property, the party executing the stall application and any entry form, on behalf of itself, its directors, officers, employees and guests and its principals and agents and their directors, officers, employees and guests (herein collectively "Persons") releases the track owner, its directors, officers, employees and agents from any direct or consequential claims, demands, actions, suits, losses, costs, charges, expenses, damages and liabilities whatsoever ("Loss"), which any such Person may pay, sustain or incur, including without limiting the generality of the foregoing, any Loss by reason of personal injury, damage to horses, or other property, including Losses related to racing purses and awards, whether or not such Loss results from or is caused by the negligence of its directors, officers, employees and agents.

The trainer, owner and their respective servants, agents and employees hereby agree that all horses and property as aforesaid on the premises of Fort Erie Race Track shall be deemed, for the purposes of this subparagraph, to be within the sole and singular care, custody and control of the owner, trainer and their respective agents, servants and employees and, further, that Fort Erie Race Track shall not be responsible for the safety and well-being of the horses, horse owners, their trainers, their principals, agents, directors, officers, employees and guests while on the premises.

- 2.] All Owners, Trainers and their employees must be licensed by the ORC AND ABIDE BY THEIR RULES.
- 3.] All **TRAINERS** at Fort Erie must have a **WSIB Clearance Certificate** covering their help & **IT MUST BE ON FILE WITH RACE OFFICE.**
- 4.] **FOAL PAPERS** must be presented to, & be on file with, the Race Office upon the horses' **ARRIVAL ON THE PROPERTY.** As per O.R.C. rule #29.08
- 5.] Stalls will be assigned to SPECIFIC horses on the application. NO SUBSTITUTIONS ARE ALLOWED WITHOUT THE PERMISSION OF THE COMMITTEE. Trainers are not allowed to LOAN stalls assigned to them.
- 6.] The applicant agrees to cooperate with the Racing Secretary in order to fully utilize the stabling facilities.
- 7.] The only allowable bedding materials will be STRAW, and SHAVINGS. All manure and bedding materials must be placed ONLY in containers designated by F.E.L.R.C.
- 8.] Absolutely no garbage in manure pits. Any violations found will necessitate fines to responsible Owners and Trainers.
- 9.] **Trainers must leave their stalls cleaned out when vacated. Failure to do so will result in a charge of \$50 'per stall'.**
- 10.] The applicant agrees to keep the stabling accommodations and adjacent areas, as well as any "storage" or "living quarter" rooms, allotted to them, in good and clean condition. They also consent to inspection of such facilities without notice. Any damages to said accommodations will be billed to the applicant.
- 11.] The applicant, for his/her self, owners of horses in his/her custody, his/her agents and his/her employees, hereby assign to F.E.L.R.C. any and all rights to motion pictures, television and radio broadcasting, in connection with races or training at F.E.L.R.C.
- 12.] F.E.L.R.C. may refuse admittance to and/or eject anyone whom it considers undesirable, in accordance with the regulations of the ORC, and that party has no right to a statement of reasons thereof, or to any form of hearing thereon.
- 13.] **F.E.L.R.C. reserves the right to refuse any entry in any RACE.**
- 14.] It is understood that F.E.L.R.C. may assign stall space for any or none of the horses listed on this application. F.E.L.R.C. reserves the right to decline stall space OR revoke the allocation of any stalls, for any reason, at any time. Any trainer and their owners, given notice to vacate the stalls and other facilities they occupy, agree to do so, and to move any and all horses, equipment and personnel from the premises, within 48 hours after receiving written notice to vacate.
- 15.] Trainers must obtain **"IN" and "OUT" SLIPS** before any horses are shipped into or out of the track.
- 16.] In cooperation with O.R.C. rule 29.15, F.E.L.R.C. requires a copy of a current negative coggins test to be turned in to the Race Office upon the horses' arrival on the property.
- 17.] All licensed individuals must be 16 years of age to paddock a horse (this includes paddock schooling)
- 18.] No emptying stalls into the shedrow at the end of the meet, stall contents must be placed in manure bins
- 19.] No yearlings are to be stabled on the backstretch at anytime during the 2017 season
- 20.] Trainers are responsible for lawn maintenance at their barn if they refuse to have it maintained by the association
