Race 1, Stewards' Inquiry regarding start of #2 Happy Quad, P. Badrie, 6th, after review of back tower and pan camera angles and speaking with the rider, it was determined the horse received a fair start and was considered dwelt.

Race 2, #4 Audax Minor, C Lee, 4th, off a step slow, rest good

Race 3, Turf, Jockey claim of foul, #1 H. Vanek aboard Rhumbaba, 6th, on #3 Wolf Beach, E. Ramsammy, 2nd after the start, and #2, I. Mosqueira, 4th, at the start. Upon review of the front tower and upper pan, #1 bore out at start to #2, #3 does come in a step, #2 is squeezed but its #1 that is the aggressor and finishes in behind #2, claim of foul disallowed, as the horses ran away from the start, #3 is coming in slightly where #3 is having difficulty and #1 does catch a heel and stumbles, it was determined #3 is not quite clear and was subsequently disqualified 2nd placed 6th behind #1, rest good.

Race 4, All clear

Race 5, on advisement of the Official Veterinarian, #4 Rapporteur, be scratched as it had sat down in the gate, refund of \$33,994. Stewards' Inquiry regarding the start of #8 Mixed Up Misfit, M. David, made a right hand turn after the start, review of the back tower revealed the horse did receive a fair start, no changes made, #1 Blazing Song, C. Lee, 6th, was away very slow with an awkward start, rest ok

Race 6, Turf, #2 Hatrixie Moment reared up behind the gate when being loaded and unseated Jockey Robert Stewart, ran off inside the infield and subsequently a Steward scratch. Refund of \$15,120. Race all clear
