Race 2, long delay as 3 horses were scratched at the gate by the Official veterinarian for being unruly or rearing up and potentially injuring themselves, #2, She's Hot to Trot, was scratched by the Official Veterinarian as #3 Bridge to Nowhere did rear and turn into the #2 stall, #3, Bridge to

Nowhere, scratched at the gate by the Official Veterinarian for rearing and getting the front limbs over the front of the gate stall, #4 Shamra, broke through the gate and ran off and was scratched by the Stewards, #5 Sigiriya was scratched at the gate by the Official Veterinarian for rearing and sitting down in the gate. Two horses, #1 Frac Amour and #6 Alta Calibre did race and were clear, total refund for race #2 was \$79,031.

Race 3, Turf, #5 Berkus, J. Alderson, 8th, hit the side of the gate stall doors upon the starter dispatching the field, compromising its start, rest ok
